- The Grand Prize winner will be determined by the person who correctly guesses the exact number of birdies made (Wed.-Sun.) during the 2015 Travelers Championship. In the case of a tie, the Grand Prize will be chosen randomly.
- If no one guesses the exact number of birdies made, then the Grand Prize winner will be the person whose guess is the closest (without going over the total) to the actual number made during the 2015 Travelers Championship.
